1. Name of the society shall be

PURBA ABASAN (FA BLOCK) RESIDENT'S WELFARE ASSOCIATION

2. The Registered Office of the society shall be situated at :

53A, B C Roy Road, Kolkata 700034

3. The objects for which the society is established are:

- a) To promote good harmonious relation amongst members of this association by organizing cultural, religious and social event at frequent interval so that the members can understand each other well and grow like members of one family
- b) To engage and assist in Philanthropic activities as may be deemed appropriate by the Governing Body of the society.
- c) To interact with Government Authorities for the welfare of the members of the Association

- e) To do all such acts, deeds, matters and things as may be deemed incidental or conducive to the foregoing objectives

6. The refuge of the West Bengal Societies Registration Act, 1961 shall not be taken to avoid the application and registration under other acts wherever and whenever required under other acts such as West Bengal Apartment Ownership Act, 1972, West Bengal Cooperative Societies Act etc.
